The legal voters of Southwest Vermont Union Elementary School District are hereby warned to meet at the Southwest Vermont Supervisory Union Administrative Office, 184 North Street - Suite 1, Bennington, Vermont, or remotely via the Zoom computer application/program utilizing meeting ID: 870 8435 6299 with Passcode: 130410 (a direct link is available on the SVSU website [www.svsu.org](http://www.svsu.org) which also lists numbers to access by phone) on **Monday, March 4, 2024, at 6:00 o'clock in the evening (6:00PM)** to transact the following business from the floor:

**ARTICLE I:** To accept the reports of the District's officers for the preceding year as reported in the Annual Report.

**ARTICLE II:** To establish the annual salaries of the District officers as follow:

- a) Moderator: \$ 100.00
- b) District Clerk: \$ 1,500.00
- c) School Directors: \$ 2,000.00 each
- d) Treasurer: \$27,673.00

**ARTICLE III:** To authorize the School Board to transfer and expend funds from the established and audited capital reserve fund for capital expenses.

**ARTICLE IV:** To transact any other business found proper when met.

The legal voters of Southwest Vermont Union Elementary School District are hereby FURTHER WARNED to meet at their respective polling places on Tuesday March 5, 2024, to transact business by Australian ballot as follows:

**ARTICLE A:** To elect from the legal voters of the District:

- One (1) Moderator for a term of three (3) years beginning July 1, 2024**
- One (1) Clerk for a term of three (3) years beginning July 1, 2024**
- One (1) Treasurer for a term of three (3) years beginning July 1, 2024**

**ARTICLE B:** To elect School Directors as indicated for such terms to begin immediately. The School Board members to be elected are as follows:

- One (1) who is a resident and legal voter of the Town of Bennington (3-year term)**
- One (1) who is a resident and legal voter of the Town of Pownal (2-year unexpired term)**
- One (1) who is a resident and legal voter of the Town of Shaftsbury (3-year term)**
- One (1) who is a resident and legal voter of the Town of Woodford (3-year term)**

**ARTICLE C:** Shall the voters of the school district approve the school board to expend \$30,032,215, which is the amount the school board has determined to be necessary for the ensuing fiscal year?

Voting at the meeting on Tuesday, March 5, 2024, shall be at large by Australian ballot. The polls will be open as indicated below for each respective town; there will be separate polling places in each of the member districts of which the voter is a resident as follows:

Residents who are legal voters from the Town of Bennington vote at the Bennington Firehouse - River Street, Bennington, Vermont. Polls will be open from 7:00AM to 7:00PM.

Residents who are legal voters from the Town of Pownal vote at the Pownal Town Office - 511 Center Street, Pownal, Vermont. Polls will be open from 10:00AM to 7:00PM.

Residents who are legal voters from the Town of Shaftsbury vote at the Town Garage - North Road, Shaftsbury, Vermont. Polls will be open from 7:00AM to 7:00PM.

Residents who are legal voters from the Town of Woodford vote at the Woodford Town Building - Route 9, Woodford, Vermont. Polls will be open from 7:00AM to 7:00PM.

**Register to Vote!** Residents of the District may register to vote at their Town Clerk's Office or online at [www.olvr.sec.state.vt.us](http://www.olvr.sec.state.vt.us). Eligible residents registering on Election Day must do so at the polling place where they will cast their Town Meeting ballot.

Application shall be made to the Clerk of the Southwest Vermont Union Elementary School District at the Clerk's regular business office during the Clerk's regular business hours, unless otherwise specified by the Clerk.

A voter, who expects to be an early or absentee voter, or an authorized person on behalf of such voter, may apply for an early voter absentee ballot until 5:00 P.M or the closing of the Town Clerk's office on the day preceding the election.
