### Development Review Board (DRB)

Date of Meeting: February 4th, 2026

Members present: Mike Day (chair), Denny Browe, Sarah Costin (by zoom), Tedd Habberfield. Russell Sleight and Zoning Administrator Carlyn Mickle was also present.

1) Call to order

The meeting came to order at 6:01 p.m.

2) Conflict of interest

No one reported a conflict of interest with any item on the agenda.

3) Sign-in sheets

Interested Persons Record and Service List and Interested Persons Oral Testimony Oath documents were signed (verbally) by applicants no abutters were present.

4) Outstanding minutes

Dr. Habberfield moved to approve the July 2<sup>nd</sup>, 2025 minutes. Ms. Costin seconded the motion, which passed 4-0-0

Dr. Habberfield moved to approve the October 1<sup>st</sup>, 2025 minutes with 2 amendments. Ms. Costin seconded the motion, which passed 4-0-0

5) Application 26-0004, parcel 12 01 24, owner Jeffery Seidel, 482 Horton Hill Rd, Shaftsbury VT:  
request for a Home Occupation.

Mr. Siedel described his insurance business which is run out of his home office. He has a sign in the yard that indicates his business. He has two employees which both work from home. His clients are primarily online with an occasional in person visitor.

Mr. Day asked for any questions, no DRB member had any. Mr. Day indicated that all details of this application are in compliance with our bylaw concerning home occupancy.
