

SPECIAL MEETING WARNING  
MOUNT ANTHONY UNION HIGH SCHOOL DISTRICT No. 14  
NOVEMBER 2, 2021

The lawful voters of the Mount Anthony Union High School District No. 14 (consisting of North Bennington Graded School District, Inc. (NBGSD), and Southwest Vermont Union Elementary School District (SVUESD)) are hereby notified and warned to meet at their respective polling places on November 2, 2021, when the polls will be open to vote by Australian ballot on the following Article:

Article 1: Shall bonds of the Mount Anthony Union High School District No. 14 in a principal amount not to exceed Three Million Five Hundred Thousand and 00/100 Dollars (\$3,500,000.00), subject to reduction by available State or federal funds, if any, be issued to finance construction of capital improvements to the Spinelli Complex (i.e., track repair, artificial turf system, multi-use building, and site upgrades) at Mount Anthony Union High School?

The polls will be open as indicated below in each of the member towns as follows:

Legal voters of the NBGSD residing in North Bennington or in Shaftsbury District 1 vote at the North Bennington Village Office, 1 Depot Street, North Bennington, Vermont. Polls will be open from 10:00 AM to 7:00 PM

Legal voters of the SVUESD residing in the Town of Bennington vote at the Bennington Fire House, 130 River Street, Bennington, Vermont. Polls will be open from 7:00 AM to 7:00 PM.

Legal voters of the SVUESD residing in the Town of Pownal vote at the Pownal Center Firehouse, Pownal Center, Vermont. Polls will be open from 10:00 AM to 7:00 PM.

Legal voters of the SVUESD residing in the Town of Shaftsbury but not in District 1 vote at the Shaftsbury Town Office (Cole Hall), 61 Buck Hill Road, Shaftsbury, Vermont. Polls will be open from 10:00 AM to 7:00 PM.

Legal voters of the SVUESD residing in the Town of Woodford vote at the Woodford Town Building, Route 9, Woodford, Vermont. Polls will be open from 7:00 AM to 7:00 PM.

The lawful voters of the Mount Anthony Union High School District No. 14 are hereby further notified and warned that a public informational meeting



RESOLUTION OF NECESSITY  
FOR CAPITAL CONSTRUCTION PROJECT

RESOLVED, at a duly warned special meeting of the Board of School Directors ("Board") of the Mount Anthony Union High School District No.14 ("District") on September 27, 2021, it was determined that the public interest and necessity demand that the District undertake a capital improvement project to the Spinelli Complex at Mount Anthony Union High School located in Bennington, Vermont, more particularly track repair, artificial turf system, multi-use building, and site upgrades, related professional fees and other costs (the "Project") at an estimated capital cost of Three Million Five Hundred Thousand and 00/100 Dollars (\$3,500,000.00); and

BE IT FURTHER RESOLVED, that the costs of the Project are too great, after the application of available State and federal funds, if any, to be paid out of the annual revenue and available resources of the District; and

BE IT FURTHER RESOLVED, that no state school construction aid funding is presently available to finance any portion of the Project costs and the District will be responsible for all costs of the Project; and

BE IT FURTHER RESOLVED, that a proposal for the issuance of general obligation bonds of the District in principal amount not to exceed Three Million Five Hundred Thousand and 00/100 Dollars (\$3,500,000.00), subject to reduction by State and federal funds available to fund such improvements, if any, to pay for the Project should be submitted to the legal voters of the District at a Special Meeting of the District to be duly called, warned and held on November 2, 2021; and


BE IT FURTHER RESOLVED, that the Board will hold a public information hearing on the bond issue proposition on October 25, 2021 at six o'clock in the afternoon (6:00 PM) at SVSU Central Office – Upstairs Conference Room and via Zoom.

BE IT FURTHER RESOLVED, that all acts relating to the proposition of incurring bonded indebtedness and the issuance of general obligation bonds of the District for the purpose of designing, constructing and making said improvements be in accordance with the provisions of Chapter 53 of Title 24, and Chapters 9, 11 and 123 of Title 16, Vermont Statutes Annotated; and


